5. Electronic bids must be submitted to the office Buddhashanti Rural Municipality Budhabare Jhapa Nepal through PPMO website www.bolpatra.gov.np. on or before 28-04-2019 12:00. Bids received after this deadline will be rejected. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

The bids will be opened in the presence of Bidders representatives who choose to attend at 28-04-2019 14:00 hours at the office of Buddhashanti Rural Municipality Budhabare Jhapa Nepal Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 125000.0NRs which shall be valid for 30 days beyond the validity period of the bid.All other issued shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement Regulation 2064.
