Buddhashanti Rural Municipality has allocated funds towards the cost of **Supply and Delivery of Four Wheel Drive Double Cab at Buddhashanti Rural Municipality Office, Jhapa** and intends to apply part of the funds to cover eligible payments under the Contract for **BRM/NCB/GOODS/082/083-10**. Bidding is open to all eligible Bidders.
2. The Buddhashanti Rural Municipality invites electronic bids from eligible bidders for the procurement of **Supply and Delivery of Four Wheel Drive Double Cab at Buddhashanti Rural Municipality Office, Jhapa** under *National competitive bidding procedures specified in Public Procurement Act and Regulations*.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Buddhashanti Rural Municipality, Budhabare, Jhapa** or may visit PPMO egp system www.bolpatra.gov.np/egp.
4. Bidder should submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, should deposit **NPR, 3000** for the cost of bidding document in the following Rajaswa (revenue) account as specified below.

5. **Pre-bid** meeting shall be held.
6. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM on Monday, July 13, 2026**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **Monday, July 13, 2026, 1:00PM** at the office of **Buddhashanti Rural Municipality**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format for e-bid, amounting to a minimum of **NRs. 1,50,000.00**, which shall be valid for 30 days beyond the validity period of the bid **Wednesday, December 9, 2026**.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Each bidder must quote for all items included in the Schedule of Requirements. Any omission or blank entry against an item shall be deemed to indicate a quotation of zero (0) for that item. Bids shall be evaluated on the basis of the total price of all items.
10. The office reserves the right to accept or reject, wholly or partly, any or all the bids without assigning reason, whatsoever.
